**BILL # 6**

**TITLE:** A Bill to clarify eligibility for floor nominations.

**WHEREAS,** - members can be nominated on the floor at Rebekah Assembly,

**WHEREAS,** - the guidelines are not clear on eligibility,

**BE IT ENACTED BY THE REBEKAH ASSEMBLY OF CALIFORNIA,** Chapter VIII, Section 13 – Elections, A. Nominations, (3) Eligibility and (4) Qualifications.

Change from:

A. Nominations.

(3) Eligibility. Any Past Noble Grand or Past Grand in attendance at the Session shall have the privilege to nominate any Past Noble Grand or Past Grand in good standing in a Rebekah Lodge in good standing who has received the Assembly Degree for any elected Office.

(4) Qualifications. Written qualifications, not to exceed one hundred words, are required for all nominees, incumbents may be excluded. They shall be presented to the Assembly Secretary, prior to April 1, so that they may be printed in the Advanced Proceedings. Additionally the following qualifications apply: (a) All Candidates:  
(i) must have written approval of their Rebekah Lodge.  
(ii) must have their dues paid one year in advance.  
(iii) must have attended (3) prior sessions of the Rebekah Assembly of California.  
(iv) prior attendance at the board meetings concerning the office for which they wish to be nominated is strongly recommended.

Change to:

A. Nominations.

(3) Eligibility. Any Past Noble Grand or Past Grand in attendance at the Session shall have the privilege to nominate any Past Noble Grand or Past Grand in good standing in a Rebekah Lodge in good standing who has received the Assembly Degree for any elected Office. **The nominee must be present at Rebekah Assembly to accept the nomination.**

(4) Qualifications. Written qualifications, not to exceed one hundred words, are required for all nominees, incumbents may be excluded. They shall be presented to the Assembly Secretary, prior to April 1, so that they may be printed in the Advanced Proceedings. Additionally, the following qualifications apply:

(a) All Candidates:

(i) must have written approval of their Rebekah Lodge.

(ii) must have their dues paid one year in advance.

(iii) must have attended (3) prior sessions of the Rebekah Assembly of California.

(iv) prior attendance at the board meetings concerning the office for which they wish to be nominated is strongly recommended.

(v) must be present at Rebekah Assembly for the nominations and voting.
